

**SECTION III**  
**(Operations and Training)**

**1. Length of Courses.**

During this month special instruction was given to members of the 445th U. S. Army Air Force Band of the Aircraft Warning Unit Training Center. These men were instructed according to the schedules of the regular courses in "Company Administration and Company Supply". All of the instruction was carried on in a very informal style. This period of instruction lasted for four weeks, three hours each day for six days a week.

**2. Training Aids.**

Many of the training aids were loaned out to Major Mitchell of the III Fighter Command. Schedules of the courses in Company Administration and Company Supply, outlines of these courses, and charts were also furnished by this department to this officer for the purpose of opening a school in Tallahassee, Florida.

**3. Scope and Nature of Training Activities.**

The members of the Army Air Force Band gathered in the "Instructors' Room" for this training. They were given an intensive course in Company Administration for the purpose of acquainting them with the duties of a personnel clerk (368). Some of these men were given special training in the Company Supply Course for the purpose of acquainting them with the work of a supply clerk (835).

Many of the supplies and pieces of equipment were turned in to B-4 of the battalion. Stoves were furnished for the buildings and coal was provided. No fires were made in the stoves during this month because an inspection was necessary of all of this heating equipment by an inspecting officer of the Aircraft Warning Unit Training Center.

**1. Instructor Training.**

Lectures were held by the officers in charge to train the men for better leadership as non-commissioned officers. A special series of lectures were given in "First Aid". Demonstrations were also given by members of the instructing staff. (References - FM 21-11, First Aid for Soldiers, dated April 7, 1943 and FM 21-10, Military Sanitation and First Aid, dated July 11, 1940.)

**2. Inspections.**

Brigadier General Sherrill and Brigadier General Larson accompanied by Lt. Colonel Stiehl and his staff made an inspection of the school area on 29 October 1943.

**3. Routine Staff Activities.**

Several meetings were held by the department head to notify the instructors and the personnel staff of current changes in the battalion policies.

Some of the instructors attended a special course in the use of the Teletypewriter for the purpose of training as instructors in this line of work.

Three of the instructors are to begin a special course in Aircraft Identification at the Information Center Department of this battalion.

Several of the buildings were loaned to the Instructors' Training Department of this battalion for their use as classrooms and an office.

During this month very little activity of importance took place. The office personnel carried on routine administrative work and the instructors were engaged in research work in the courses of Company Administration and Company Supply.

1. A new schedule of student output was set up during December 1943 to conform to anticipated requirements for the next few months. On the basis of these new course expansion, the Department will probably be reorganized in the near future to meet this new condition.

2. The newly organized 502-615 Operators course had its first students enrolled on 20 December 1943. This course is under the direction of 2nd Lt Harold T. Smith who studied the set at the Westinghouse factory at Baltimore, Md. The course of instruction will attempt to make the student familiar with the method of operation outlined in a tentative SOP for the 502-615 recently completed by members of this department.

3. The gasoline shortage that developed the week before Christmas forced us to move the 602 Operators course from the Cal Brewer Site to the Main Radar area before the new expanded area was completed. All activity at the Cal Brewer Site was discontinued except for the guards on 20 December 1943.

4. A new SOP for the 502-508 was received from Army Air Force in Washington, D.C. This SOP which contained minor changes over the one used previously was adapted to the 527-508 Operators course immediately.

5. All during the month of November 1943, there was great pressure on from higher headquarters for trained 502-602 Operators. The peak enrollment was reached during the week of 29 November 1943 when 304 students were enrolled in the 502-602 Operators Course. For the two weeks following, there was practically no enrollment in this course due to the sudden lowering of commitments of U-teams on 2/0 11-400. By 27 December 1943, the enrollment had dropped to 60 students, which indicates the great change in enrollment this department must be prepared to accommodate.

### SECTION IV

#### MATERIAL AND SUPPLY

1. Building 11-b-138 was moved out of the area by the base engineers through the north fence. This building had previously been used as a classroom. The moving of this building marks the first step in an extensive program to replace some of the poorly ventilated and poorly lighted buildings now used as classrooms by this department.
2. The gasoline shortage that developed the week before Christmas caused the greatest disturbance of activities experienced in the department for some time. Great stress was laid on getting all sets converted to commercial power. By a series of temporary cable splices, most of the SCR-527 sets were tied into the existing commercial power circuits used for the SCR-271's. As luck would have it, seven 5 H.P. electric motors were received by this department to be used in place of the Briggs & Stratton gasoline engines to drive the SCR-602 generators. These motors had previously been ordered on 6 March 1943 for this very purpose.
3. The SCR-615 set located in the Main Radar Area was transferred from the 4th Training Battalion back to the 38th Signal at sea and the Radar Department. (\*) This set is to be used in the newly organized SCR-615 Operators course.

## SECTION LII (Operations and Training)

### 2. Experimental Practices

To better train students in operation of an Information Center in the field plans were made, and installations are well underway of a receiving and plotting unit in the Information Center Department. The hutment formerly used as a Radio Supply is being prepared to receive Radar Reports from units in operation in the vicinity of Tampa and Tarpon Springs. The receiving unit in the Radio Hutment will be equipped with six XI-28 Radios; voice or C.W. transmission will be used. From here, the reports will be relayed to the Information Center which consists of a room equipped with a TC-15. Standard Operational procedure will be used in the display and filtering of these reports. These reports will be of actual activity of aircraft in flight over Florida.

In the meantime, instructors in the Information Center Department were oriented in the use of the TC-15, portable Information Center. With the aid of the Wire Section the instructors were taught how to operate the power unit, set-up of the filter table, and to make proper connections of the different communication units within the Information Center. This will prove to be of valuable experience for the instructors in the set-up of Information Center equipment in the field, as operation taught in this unit is mainly for a fixed system of Air Defense.

In the Ground Observers Section of the Information Center Department, instruction in the course of Aircraft Recognition continued to use the Renshaw System. To avoid confusion of Radar and Ground Observer Information on the filter board white arrows only will be used.





**2. Requests Received.**

S-3 Section, 1st Signal AM Training Battalion requested recommendation for a schedule of enrollment of students in the GII Operators Course. Was advised that it would be best to enroll ten (10) students per week, thereby meeting the output of forty (40) per month required by ANUSC.

The desirability of moving in an EG 188 from the Col. Brewer Site if possible, was also discussed; even though an SCR-588 were not moved with it. Captain Ray is going to discuss all phases of this course with Col. Griffin and will advise Captains Delaney and Coffman of the results.
